On-Site Onboarding Sessions – COMPLETE YOUR I-9, SECTION 2

You may attend any of the locations, dates, and times shown below to complete your I-9, Section 2 with UCI Health Human Resources. Please come with the identification documentation you used to complete your I-9, Section 1. UCI Health Human Resources will need to physically inspect your identification documents.

As a reminder, the following are some of the more common, approved documents that can be used for completion of your I-9, but please review the complete list of acceptable documents to ensure your I-9 process goes smoothly.

- U.S. Passport or U.S. Passport Card
- Permanent Resident Card or Alien Registration Receipt Card (Form I-551)
- Foreign passport that contains a temporary I-551 stamp or temporary I-551 printed notation on a machine-readable immigrant visa
- Employment Authorization Document that contains a photograph (Form I-766)
- Foreign passport with Form I-94 or Form I-94A with Arrival-Departure Record, and containing an endorsement to work

You may meet with UCI Health Human Resources at any time during the open times shown below - no appointment is necessary. I-9 processing time takes about 10 minutes; however, the total time to complete this transaction will be dependent upon the number of other co-workers in line ahead of you.

Additionally, representatives from UCI's Employee Experience Center (EEC) will be on-site to answer any questions you have related to onboarding, benefits, retirement, etc.

Thank you, and we look forward to helping you take this important step in your transition to becoming a UCI Health co-worker.
