## Health > Intermittent Absence Reference Guide

- Employee's must follow their local call-in procedure.
- If the leave is Intermittent All absences under FMLA must be reported to Sedgwick within 5 calendar days from date of absence.
- <u>When</u> the employee's intermittent or continuous leave is <u>approved</u> by Sedgwick, the Supervisor will enter the FMLA start date into API, this will allow the FMLA codes to be accepted in API.
  - In API under Employee section, click on the General Tab, and then click on the Parameters tab, enter the FMLA start date, and the CFRA (State) start date and save. See screenshots below.
- The employee is responsible for entering the FMLA/CFRA pay codes within their timecard.
  - I would recommend for the Supervisor to verify the employee is reporting their absences correctly in API as well as to Sedgwick.
  - If the leave is Intermittent Please note it is imperative for the employees report their absences to Sedgwick, this ensures their FMLA absences hours are being deducted from their overall leave entitlement.
- If the FML codes are rejected by API; Supervisors, please ensure the FMLA and CFRA start dates were entered correctly.
