OTHER OE CONSIDERATIONS

IF you are satisfied with your current medical, dental, vision, legal, supplemental health, or other coverages, then you do **<u>NOT</u>** need to take an action during Open Enrollment

• Your coverage will automatically carry over into the next plan year.

2024 RETIREE MEDICAL CONTRIBUTIONS

- UC aggregate contribution remains at floor of 70%
 - Non-Medicare (pre-65 retirees)
 - Medicare-eligible retirees in California
- Contributions for non-Medicare retirees ages 65+ align to average contributions paid by UC Medicare retirees
- Medicare Coordinator Program for Medicare-eligible retirees outside of California
 - Continued UC contribution up to \$3,000 per enrolled individual to a Health Reimbursement Arrangement (HRA) to help pay for eligible health expenses, including Medicare Part B

 - \$0 Member Cost Share
 - Deductible applies for UC HSP and CORE
- > OON Vasectomy member cost share remains the same
 - HSP at 40% after deductible
 - UC Care at 50% after deductible
 - CORE at 20% after deductible

- > Inflation Reduction Act \$0 member liability in the catastrophic phase
 - New Threshold \$8,000 (from \$7,400)
 - \$0 Member Cost Share
- > Low-Income Subsidy (LIS) and True Out-of-Pocket (TrOOP) Amounts are changing
- New Vendor for Post-discharge Meals
 - From Mom's Meals to Roots Food Group Management

Public Law No: 117-328/HR 2716:

Coverage of MFTs and MHCs as Medicare providers

- Members can see state-licensed MFT and MFCCs for Medicare-covered outpatient behavioral health services. \$20 copayment.
- 2023: To use this benefit, members may need to pay the full cost and then submit a reimbursement claim.
- > 2024: Providers may submit claims directly to UnitedHealthcare for reimbursement.

2024 Inflation Reduction Act (IRA) Medicare Part D

IRA provision will enhance coverage for Medicare participants with high prescription costs

- Ø No out-of-pocket drug costs after the catastrophic coverage phase of \$8,000 in 2024
- Ø Impacts Kaiser Senior Advantage, UC Medicare Choice PPO
- Ø Additional catastrophic drug coverage with the Medicare Coordinator Program, administered by Via Benefits, ends 12/31/23

Kaiser Senior Advantage Mandatory Change

Discontinuing Post-Discharge Meal Delivery

- Launched in 2021 to lower readmission rates of congestive heart failure (CHF) patients
- Provided meals for 4 weeks (up to 56 meals) immediately following hospital discharge with principal diagnosis of CHF
- Authorized to qualifying members through 12/31/23; members must accept benefit within 30 days of discharge
- Authorization/procedures to continue through Q1 2024
